

**Resolution of the Board to Set Tax Rate
(If Maintenance and Operations Tax Revenue Will Exceed Previous Year)**

Date: August 12, 2024

On this date, we, the Board of Trustees of the Stockdale Independent School District, hereby levy or set the tax rate on \$100 valuation for the District for the tax year 2024 at a total tax rate of \$ 0.974500, to be assessed and collected by the duly specified assessor and collector as follows:

\$ 0.666900 for the purpose of maintenance and operations, and

\$ 0.307600 for the purpose of payment of principal and interest on debts.

Such taxes are to be assessed and collected by the tax officials designated by the District.





THE TAX RATE WILL EFFECTIVELY BE RAISED BY 10.61% (*insert percentage by which the tax rate exceeds the no-new-revenue maintenance and operations rate*) PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$ -2.30 (*insert amount*).
